RESEARCH PROGRAMME PLAN

- (1) On-line EMR system to track efficacy, control, side-effects (ADR), and clinical well-being of persons with type 2 DM, under different treatment regimes – 2 year study (on-going 5 year project)
- (2) Comparison of the metabolic impact of Modern Medicine (and glycaemic-Index Diet) Vs. Ayurvedic approach (with Ayurvedic diet) in Mild to moderate, Nonketotic, NIDDM (type 2 DM) – 2 year study of recently detected cases (on-going 5 year study)
- (3) Metformin and Kidney Disease: Tracking the Renal parameters & clinical progress in persons with Type 2 DM with and without Metformin.

ENERGY MEDICINE RESEARCH

- (4) Pulsed Electro Magnetic Field Energy (PEMFE) Therapy and its applications in type 1 and type 2 DM: Long term (5 year) study using on-line EMR tracking system with periodic (yearly) Report of Analysed Data.
- (5) The usefulness of PEMFE in the absorption of S/c Insulin in type 1 DM & IRDM (type 2) – 2 year study.
- (6) The Role and Results of PEMFE in Ischaemic Heart Syndromes (CAD) in type 2 DM patients and controls (non-diabetics) – 2 year study.
- (7) The Role and Results of PEMFE in Cerebro Vascular Strokes, Dementias, Dysphasias, in type 2 DM patients and controls (non-diabetics) – 2 year study.
- (8) Diabetic Foot Ulcerations & Wound Healing in type 1 and type 2 diabetics: A comparison of Different modalities of treatment viz. Conventional, Pulsed Galvanic stimulation using Silverthera Socks and Pulsed Electro Magnetic Field Energy (PEMFE) therapies – 2 year study.
- (9) Relief of Neuropathic pain of different etiologies: Comparison of Conventional, Electrical (Silverthera, TENS), and Electro Magnetic (PEMFE) therapies – 2 year study.
- (10) Efficacy of PEMFE Therapy in acute painful abdomen, post operative abdomen and chronic digestive disorders – 2 year study.
- (11) The Application of PEMFE in gynaec conditions PCOS/PCOD, dysmenorrhoea, Uterine Fibroids and other gynaecological conditions – 2 year study
- (12) PEMFE and the Eye
 - a) PEMFE in diabetic macular oedema - Complimenting Photocoagulation.
 - b) PEMFE in Non-Proliferative Diabetic Retinopathy (NPDR – advanced), and Proliferative Diabetic Retinopathy (PDR) - Complimenting Photocoagulation.
 - c) PEMFE in Ischaemic Optic Nerve Syndromes (Papillopathy)
 - d) PEMFE therapy to prevent corneal rejection in Corneal transplants in type 2 DM
 - e) In Glaucoma
 - f) In Age related macular degeneration (AMD)
 - g) In Retinitis Pigmentosa (RP)
